Understanding Healthcare Effectiveness Data and Information Set (HEDIS®) measures is important to delivering high-quality care to our members, your patients. These evidence-based metrics assess the quality of care provided to patients in various areas, including preventive care, chronic disease management, and behavioral health.

HEDIS measures play a critical role in ensuring our members receive high-quality care that meets nationally recognized standards. By tracking and reporting HEDIS measures, we can:

- Identify areas for quality improvement
- Evaluate the effectiveness of care management interventions
- Make informed decisions about care delivery and resource allocation

### Key Focus Areas

- **Behavioral Health and Substance Use**

Help us enhance care for mental health and substance use for Florida Blue members. We urge you to prioritize follow-up visits within seven and 30 days for patients with substance use and mental health conditions. By scheduling and conducting these timely follow-up visits, you can help prevent relapse, reduce hospital readmissions, and improve patient outcomes. The following HEDIS measures help support this key focus area:

- **Cancer Screenings**

Take a proactive approach to cancer care by prioritizing HEDIS measures for breast, cervical, and colorectal cancer screenings. Ensure your patients receive timely and effective screenings, as recommended by guidelines, to detect cancer at an early stage and improve treatment outcomes.

- **Statin Therapy**

Prescribe a 90-day medication supply when possible and promote the home delivery option to your patients. This can help improve their adherence and close the care gap.
