The July 1, 2025 updates include, but are not limited to, the new **Tryvio**MCG for the treatment of resistant hypertension. This modification also shows a new **Vanrafia** MCG which is indicated to reduce proteinuria in adults with primary immunoglobulin A nephropathy (IgAN) at risk of rapid disease progression.
