

## 2026 Medicare Advantage Provider Quality Bonus Program


We are pleased to announce our 2026 Medicare Advantage Provider Quality Bonus Program (“Bonus Program”). The Bonus Program is offered to all in-network primary care provider (PCP) groups contracted with any of the Florida Blue Medicare Advantage product lines (HMO and Local PPO) for the performance year. Eligible provider groups may receive an annual bonus for delivering care that results in positive clinical outcomes for their patients covered in a Florida Blue Medicare Advantage HMO or PPO health care plan.

The program aligns with the Centers for Medicare & Medicaid Services’ Five-Star Quality Rating System. It is also consistent with various Healthcare Effectiveness and Data Information Set (HEDIS<sup>®1</sup>) and Pharmacy Quality Alliance<sup>2</sup> measures to evaluate clinical outcomes.

New this year, the bonus program now includes two custom bundles, **Elderly Safety and COPD Management**, each with five quality measures. Additionally, custom measures in the **Diabetes, Hypertension, Preventive, and Transitions of Care Management program bundles** are included in the Bonus Program.
