




Autonomous Advanced Practice Registered Nurses Serving as Primary Care Providers

Autonomous Advanced Practice Registered Nurses (APRNs) who work in an individual practice are eligible to contract with Florida Blue and Truli for Health (Truli) as a primary care provider (PCP) for all plans. Group-affiliated Autonomous APRNs are subject to the terms of the group's contract. The group must also provide approval to their Florida Blue and Truli Network Manager for the APRN to be recognized as an Autonomous PCP.

Autonomous APRNs associated with a group or practicing individually and already contracted with Florida Blue or Truli may notify each company of their autonomous qualification through Availity^{®1}. This can be completed by selecting "Autonomous" from the drop-down menu in the "License Qualification Type" field within Availity's-registration and maintenance screens. See screen image from Availity below.

The License Qualification Type is an optional field in Availity. If 'Select One' displays in the field, then the data is not passed to Provider Connect. Autonomous must be selected for it to be passed downstream.



All other eligible individual Autonomous APRNs who want to contract with Florida Blue or Truli should follow the Letter of Interest process located at Availity.com. Please reference the Provider Data Management instructions for additional information.

General Credentialing Information:

In addition to the Letter of Interest process, any Autonomous APRN who would like to participate as a PCP in our plans, must complete the following credentialing requirements as soon as possible:

- Access the Council for Affordable Quality Healthcare (CAQH) website located at https://www.caqh.org. to complete the application. Please remember to include Florida Blue and/or Truli on the release of information to expedite the process.
- If the provider does not have access to the CAQH website, they may find the Florida Blue or Truli practitioner application via the CVO website at https://bcbs.webcvo.net/.

Once an Autonomous APRN PCP is contracted and credentialed with our plans, their profile details will display and be searchable under 'Primary Care' within the Online Provider Directory. They will also be available for member selection and assignment.
