We are pleased to share the latest enhancements to our Provider Portal. We have added member care program information and made a slight format change to the PDF export data in both the ProviderVista (Commercial member data) and Provider Link<sup>™</sup> (Medicare Advantage member data) platforms.

The following care programs are currently visible in the Provider Portal:


- Advanced Care Planning

- Lucet Behavioral Health Care program



### **Enhancement: Care Programs added under Clinical Insights**

In the *Clinical Insights* section in **ProviderVista**, we have added care programs labeled as **Florida Blue Care Programs** and **Care Partner Care Programs** in a view called **Care Management.** In this view, users can see the care programs available to Florida Blue patients.




Each Clinical Insights category displays patient data related to each care program including the program status, behavioral health indicator(s), and historical enrollment details. This allows you to address any changes or risks associated with your patient.

### **Enhancement: Care Programs added under Member Snapshot**

In the *Member Snapshot* view in both **ProviderVista and Provider Link**, we have added **Florida Blue Care Programs** and **Care Partners Care Programs** tiles. Users will have the ability to view additional care program details by individual program. Also, a status pie chart has been added to indicate the program includes Behavioral Health and overall care program status. To access the Member Snapshot view, simply click anywhere within the individual member line throughout any of the portal categories in Clinical Insights.




