## New BlueMedicare PPO Policy for Diabetes Glucose Monitors and Supplies

On January 1, 2025, a new policy will change how members in BlueMedicare PPO Medicare Advantage health plans obtain their diabetes glucose monitors, associated supplies, and insulin administered by pump. These products will still be covered under the medical (Durable Medical Equipment) benefit but will be distributed by in-network retail and home delivery pharmacies. *Learn more>>*
