Advance Care Planning


Advance Care Planning is an important step in ensuring that Florida Blue Medicare members' health care wishes are respected and your loved ones are prepared to make decisions on your behalf if you become unable to communicate.

What is Advance Care Planning?

Advance Care Planning, also referred to as Advance Directives, is the process of making decisions about the medical care you would want to receive if you become unable to communicate or make decisions for yourself. It involves creating a set of instructions, often in the form of written documents, that outline your wishes for end-of-life care, medical treatment, and other health care decisions. It is part of a bigger program that includes different types of care management, such as case management, health management, and behavioral health.

Advance Directives are legal documents that can include:

- A living will, which specifies the types of medical treatment you want or don't want
- A durable power of attorney, which appoints someone to make medical decisions on your behalf
- Other documents that outline your wishes for end-of-life care, organ donation, or other medical treatments



Why is Advance Care Planning important?

- Make informed decisions about your care
- Ensure that your wishes are respected
- Reduce stress and uncertainty for your loved ones
- Improve your quality of life
