
Johnson & Johnson Information Added Updated Guidelines for COVID-19 Vaccine Billing

We are committed to ensuring our members can obtain the COVID-19 vaccines quickly and conveniently. As you administer the three vaccines that have received emergency use authorization (EUA) by the Food and Drug Administration, we want to make sure you have the coding information to submit accurate claims for **administering** the vaccines. **We have updated the table below to include the Johnson & Johnson single dose vaccine that received EUA Feb. 27.**

Florida Blue Medicare Advantage

Providers should submit claims for COVID-19 vaccines to Original Medicare through your Medicare Administrative Contractor (MAC) as outlined in the Medicare institutional and professional instructions [here](#). If a provider bills Florida Blue for a vaccine or vaccine administration for a Medicare Advantage member, it will not be reimbursed. If submitted through Availity^{®1}, it will be returned electronically.

Florida Blue Medicare follows guidance from the Centers for Medicare and Medicaid Services (CMS), so please continue to check Medicare updates for vaccine information at [cms.gov](https://www.cms.gov).

Other Lines of Business

Since the federal government is covering the cost for the initial doses of the vaccine, providers only need to submit a claim for the vaccine administration. Please submit your appropriate administration fee for the corresponding vaccine, using the code information below for your Commercial, Truli for Health and Federal Employee Program[®] members. The administration fee is covered at 100 percent of your contracted allowance, with no cost share for the member.*
