#### Biosimilars Required Before Neulasta/Neulasta OnPro for Commercial Plans

On October 1, 2024, our commercial plans will require the use of the preferred biosimilars prior to covering Neulasta or Neulasta OnPro for members. This only applies to our members in a commercial plan who are newly initiated on treatment. It does not apply to Medicare Advantage plans. *Learn more>>*
