D-SNP Basic Training Required for Medicare Advantage HMO Provider Groups

The Dual Eligible Special Needs Plan (D-SNP) Model of Care has training requirements set by the Centers for Medicare & Medicaid Services (CMS). Health care providers and staff contracted by managed care organizations who deliver care to D-SNP members are required to complete the D-SNP Model of Care basic training. **Complete the training before December 31**. <u>Learn more>></u>

Florida Blue is aware of a product discontinuation initiated by Pine Pharmaceuticals that could impact the supply of compounded bevacizumab (Avastin) for ophthalmic use. Compounded bevacizumab is a preferred product included on the list of Step Therapy medications defined by Florida Blue.
